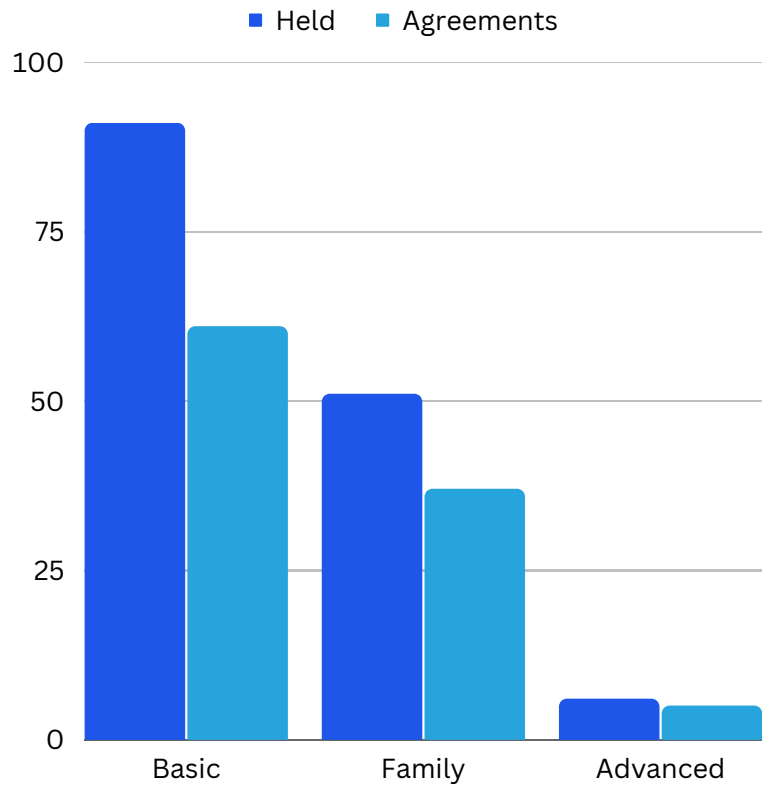
102 Referred
